Local citizens will be allowed to dispose of passenger vehicle tires and truck tires at the Public Works Department, which is located at 2365 Pinehurst Byromville Road. Tires will be accepted from 8:00 AM - 5:00 PM on Monday thru Saturday (December 4 – 9) and Monday thru Thursday (December 11 – 14). Tires must be generally clean and without rims.
