5. FY2019-2020 Budget. The Board of Commissioners have tentatively agreed to set the 2019 Millage Rate at 19.000 mills. This is an increase of 0.945 mills over the 2018 Millage Rate of 18.055. To comply with State Law, the Board will conduct three Public Hearings on the proposed tax increase. Public Hearing #1 will be held at 10:00 AM on Thursday, September 12th, at the Dooly County Commissioners Office; 113 N. Third Street; Vienna, GA. Public Hearing #2 will be held at 6:30 PM on Thursday, September 12th, at the Dooly County Commissioners Office; 113 N. Third Street; Vienna, GA. Public Hearing #3 will be held at 10:00 AM on Thursday, September 19th, at the Dooly County Commissioners Office; 113 N. Third Street; Vienna, GA. This tentative increase will result in a millage rate of 19.00 mills, an increase of 0.945 mill. Without this tentative increase, the millage rate will be no more than 18.055 mills. The proposed tax increase for a home with a fair market value of \$100,000 is approximately \$37.80. The proposed tax increase for non-homestead property with a fair market value of \$300,000 is approximately \$113.40.
