**Regular Meeting Minutes  
July 28, 2022

The Dooly County Board of Elections and Registration Board meeting was called to order by Chairperson Betty Bryant at 6:00 p.m. on Thursday, July 28, 2022 at 402 Hawkinsville RD., Vienna, GA.

## **Invocation**

The invocation commenced with Chairperson Betty Bryant leading the Board in prayer followed by The Pledge of Allegiance in unison.

## **Agenda Adoption**

The Board reviewed the agenda. Upon a motion by Vice-Chairman Wayne Wilkin and seconded by Gwendolyn Ford to adopt the agenda as presented; agenda was unanimously adopted and approved.

## **Approval of Minutes**

The Board reviewed the minutes for June 23, 2022 regular meeting. Upon a motion by Earl Clark and seconded by Gwendolyn Ford to approve the minutes for June 23, 2022, the minutes were unanimously adopted and approved as presented.

## **Budget Report (June 2022)**

The Board members reviewed the budget report for June 2022. The Board members accepted the budget report for June 2022 as presented.

The Board members along with Elections Supervisor Brenetta Childs discussed the proposed budget for FY22-23. Upon motion by Lee Harris and second by Wayne Wilkin, the Board members unanimously agreed to cut the budget by 10% of the total budget for \$24,417.90 effective immediately and instructed Elections Supervisor Brenetta Childs to notify Steve Sanders of their decision.

Upon a motion made by Earl Clark and seconded by Wayne Wilkin the Board members unanimously agreed on a 2,000.00 yearly raise increase for Jessica Fudge.

## **Voter Residence Concerns (Wayne Wilkin)**

Election Supervisor Brenetta Childs read the email from the County Attorney, William Gregor, concerning the complaint of a voter residence. Board member Lee Harris stated he had spoken with County Administrator Steve Sanders and the voter concerning the matter. Unless a formal complaint is made the matter is closed. Board member Lee Harris also requested Election Supervisor Brenetta Childs for a form to use for future reference. Election Supervisor Brenetta Childs will have a form and applicable codes at the next meeting.

**Upcoming Elections**

Elections Supervisor Brenetta Childs updated the Board members about the qualifying period for the Special Election for Board of Education, District 3 and about the upcoming General/Special Election that will be held on November 8, 2022.

The next regular meeting will be held on Thursday, August 25, 2022 @ 6:00 p.m. at 402 Hawkinsville, Road, Vienna, Georgia.

With no further business to discuss, the meeting was adjourned at 7:04 p.m.
