The regular meeting of the Dooly County Commissioners was held this date at 9:00 AM at the Dooly County Commissioners' Office in Vienna. The owners of the property are Cedric and Heather Cobb. The Planning Commission conducted a Public Hearing on the matter on February 12. The Planning Commission voted unanimously to recommend that the County Commissioners approve this Conditional Use. Brian Devine with General Dynamics was present and spoke in favor of the Conditional Use. No comments were received in opposition to the Conditional Use. The Public Hearing was closed.

**ZONING REQUEST – CONDITIONAL USE – TAX PARCEL #101-7**
