## G.D.O.T. LOCALLY OWNED BRIDGES PRIORITIZATION

The Georgia Department of Transportation is currently evaluating locally owned bridges for possible future replacement. GDOT has submitted a list of posted (load rated) off-system bridges in our jurisdiction and requested our priorities for further evaluation for one of GDOT local bridge programs. Public Works Director Rodney Hair suggested the following priorities: (1) Heath Road @ South Prong Creek; (2) Mount Vernon Road @ Turkey Creek; (3) Mashburn Road @ Wildcat Creek Tributary; (4) Third District Road @ South Prong Creek; (5) Third District Road @ Cedar Creek; (6) Godwin Bridge Road @ Turkey Creek Overflow; and, (7) St. Johns Road @ Camp Creek. The Board instructed Administrator Sanders to submit this list to GDOT.

#### AG GEORGIA

Jeremy Register with Ag Georgia presented a \$5,000.00 check to the Vienna Volunteer Fire Department from Ag Georgia's Community Mission Fund. VVFD Chief Phillip Warren thanked Ag Georgia for these funds and stated that the funds will be used for equipment for a fire truck.

#### **DOOLY JUSTICE CENTER- SEWAGE DISPOSAL**

Last year, the County installed a sewage grinder at the Justice Center to eliminate issues with sewage disposal. Building Maintenance Supervisor Brandon Christmas reports that the Justice Center is still having issues with sewage disposal. The Commissioner recommended that the company should be contacted to resolve this issue.
