- 4. The Georgia Department of Transportation is accepting applications for funding from the FY 2025 LMIG Program. Applications must be received by 02/01/2025. Dooly County is eligible for \$733,811.84. A 10% local match is required.**

5. The ACCG and GMA are hosting an online joint training session for counties and cities on House Bill 581. This legislation passed during the 2024 Georgia General Assembly and will result in significant changes to property and local sales tax systems if approved by the voters in the November 5th General Election. An online webinar will be available on Wednesday, October 16, at 1:00 PM at the County Commissioners Office.

6. The ACCG has scheduled their 2024 Fall District Meetings. Dooly County is in District 8. The District 8 Fall Meeting is scheduled for Wednesday, October 30, in Stewart County.

7. Waste Management has prepared a draft contract for Residential/Commercial Garbage Collection for service beginning 01/01/2025.

8. EMS Director Don Williford requests authority to order a new ambulance.

9. The Georgia Department of Transportation has identified two bridges as potential candidates for replacement under the State's FY2025 Low Impact Bridge Program (LIBP). GDOT has scheduled an online meeting to review these projects at 9:00 AM on 12/05/2024. The bridges are: Heath Road @ South Prong Creek; and, Mount Vernon Road @ Camp Creek. GDOT has identified the proposed detour route for each proposed project. GDOT wants to know if the County has any concerns about the proposed detour routes?
