Agenda Adoption

The Board reviewed the agenda. Upon a motion by Alex Jones and seconded by Gwendolyn Ford to adopt the agenda as presented; the agenda was unanimously adopted and approved as presented.

Approval of Minutes

Budget Report (April 2025)/ Worksheet for FY25-26

Elections for 2025 (Runoff * if applicable)

- A. Special Primary Public Service Commissioner: June 17, 2025/ July 15, 2025
- B. General/Special Election: November 4, 2025/December 2, 2025

Assistant Elections Supervisor Jessica Fudge also informed the Board members of the following:

- A. Early voting for the June 17, 2025 Special Primary Election will be held May 27, 2025 until June 13, 2025 from 8 a.m. until 5 p.m. daily.
- B. Saturday voting will be held May 31, 2025 & June 7, 2025 from 8 a.m until 5 p.m.
- C. The last day to request an absentee ballot will be June 6, 2025

The next regular meeting will be held on Wednesday, June 18, 2025 @ 5:00 p.m. at 402 Hawkinsville, Road, Vienna, Georgia.
